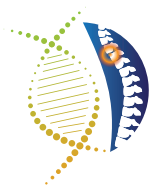

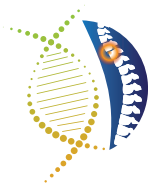

TERMS & CONDITIONS

Section 1: Delegates

To confirm and reserve the seat, all fees must be paid during the online registration and incomplete registration must be paid no later than 5 business days prior to the event. Any unpaid registrations after such time will be cancelled and re-registration online or onsite is required.

Any other discounts offered by PEMS (including team discounts) must be paid at the time of registration. Discount offers cannot be combined with any other promotions.

Substitution, Cancellation and Refund

The registrant may substitute delegate by providing reasonable notice to PEMS, 7 days before the event.

All cancellation requests must be made in writing. A 90% refund will be granted when the cancellation request is received 10 business days, 60% refund will be granted if the request is received less than 10 business days, while no refunds will be granted if the request is received less than 24 hours prior to the event. If the registrant did not show up in the event without prior notice, the registrant will be liable for the entirety of the registration fee.

If the event is cancelled by the organizer, registrants may be extended a full refund (100%) or credit can be used to attend other events hosted by the company. Refund will be processed within 30 days.

Section 2: Sponsors

If a Purchase Order (PO) application or other approval documentation is required by the sponsoring company prior to confirming the participation, all relevant paper works must be sent from the organization at the time of booking request. The organizing company reserves the right to reassign any sponsorship package/exhibition booth to another sponsoring company if below conditions are not fulfilled. By submitting this form, you are confirming your participation in this conference and a tax invoice will be issued on the receipt of your booking confirmation.

1. Obligation of the Parties:

- a. PEMS will manage and organize the Conference with the utmost professionalism.
- b. Second Party shall pay the amount of the selected sponsorship package to PEMS for sponsoring the Conference.
- c. Second Party shall pay the amount 100% in advance upon execution of this Agreement.
- d. Second Party shall be liable to invite their guests at their own costs.

2. Cancellation

In the event the sponsorship amount is paid by the Second Party and Second Party decides to terminate this Agreement, then below mentioned cancellation amount will be forfeited:

- a. 30 days before the Conference- 25% of the sponsorship amount will be forfeited.
- b. After 31st day- before 20 days of the conference- 50% of the sponsorship amount will be forfeited.

- c. After 21st day – till one week before the conference- 75% of the sponsorship amount will be forfeited.
- d. Between one week- On the day of Conference 100% of the sponsorship amount will be forfeited. In the event the Conference is cancelled the Second Party shall be reimbursed with the total sponsorship amount.

3. Termination

- a. This Agreement will be automatically terminated upon the completion of the Conference.

4. Confidentiality

The Parties agree that they will at all times (both during the term of this Agreement and after its termination) keep confidential and will not use the other Party's Confidential Information (other than strictly for the purposes of this Agreement and enforcing it) and will not without the prior written consent of the other disclose to any third party any confidential information belonging to the other unless the information:

- Was public knowledge or already known at the time of disclosure; or
- Subsequently becomes public knowledge other than by breach of this Agreement; or
- Subsequently comes lawfully into the possession of that party from a third party.

To the extent necessary to implement the provisions of this Agreement (but not further or otherwise) each party may disclose confidential information to customers or prospective customers, to any relevant governmental or other authority or regulatory body, and to the member of the same group of companies, and to any employees of either party or any of the above.

5. Force Majeure

The obligations of each Party under this Agreement shall be suspended during the period and to the extent that that party is prevented or hindered from complying with them by any cause beyond its reasonable control including compliance with any law or governmental order, rule, regulation or direction, accident, breakdown of equipment or machinery, difficulty or increased expense in obtaining materials, electricity or internet access.

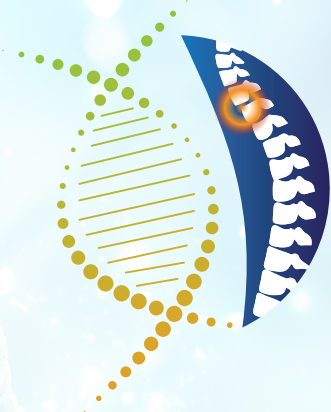
6. Jurisdiction

Any dispute between the Parties shall be resolved in accordance to the laws of United Arab Emirates and courts of Abu Dhabi shall have the exclusive jurisdiction for such disputes.

7. Time shall be of essence of this Agreement.
